**Qualifications Categories:**

**Certified** *Federally Certified Court Interpreter (Certified)*

The Certified qualification category applies to interpreters who have passed the written and oral components of the Federal Court Interpreting Certification Examination (FCICE). To date, the Administrative Office of the United States Courts (AO) has developed certification programs for **Spanish, Navajo, and Haitian Creole**. However, federal certification is currently offered only for Spanish based on the primary interpreting needs of the federal judiciary.

**PQ\*** *Professionally Qualified (PQ)*

Except for Spanish, Navajo, and Haitian Creole, the Professionally Qualified qualification category applies to any language tested by the organizations listed below. Therefore, the Professionally Qualified interpreter must be one of the following:

1. A U.S. Department of State Office of Language Services (Seminar Level Interpreter or Conference Level Interpreter),
2. A United Nations Interpreter,
3. A current member in good standing of the International Association of Conference Interpreters (AIIC) or The American Association of Language Specialists (TAALS), or
4. An interpreter included in the Registry of Interpreters for the Deaf (RID) Sign Language with a Specialist Certificate: Legal (SC: L).

**LS\*** *Language Skilled (LS)*

An approved interpreter who is not Certified or Professionally Qualified will be considered Language Skilled. Interpreters in the Language Skilled qualification category may or may not hold credentials such as those listed below:

- Administrative Office of the Illinois Courts (AOIC) Language Access Program, State Interpreter Certification or State Interpreter Registration,
- Certification or Registration in another state's Language Access Program under the National Center for State Courts (NCSC), or
- Certification by professional interpreter/translator associations or organizations in legal or court interpreting

**\*NOTE:** The Professionally Qualified and Language Skilled interpreters listed in the Roster have not been tested by the AO. Consequently, neither the AO nor the Court can attest to the level of court interpreting proficiency, or the specific court interpreting skill set possessed by the Professionally Qualified and Language Skilled interpreters listed in the Roster.
