IT IS FURTHER ORDERED That

- (a) Ms. Eileen M. Letts is designated as Chairperson of the Merit Selection Panel.
- (b) Ms. Verneé Green and Ms. Kali Thomas are designated as the two non-attorney members of this Merit Selection Panel.
- (c) The Merit Selection Panel shall submit to the court a combined list of eight candidates it finds to be the best qualified from the group of applicants who timely filed a completed application for the position announcement of U.S. Magistrate Judge-Chicago 2024-16 and those applicants that applied to position announcement of U.S. Magistrate Judge-Chicago 2024-28. The eight candidates will be considered for the magistrate judge positions for this General Order and General Order 24-0005.
- (d) The Merit Selection Panel shall file its report with the Court within ninety days of the Panel's appointment for distribution to and a selection decision by the District Judges of the Court. The Panel shall submit its report to the Chief Judge by May 14, 2024.
- (e) Pursuant to the Regulations of the Judicial Conference of the United States Courts Establishing Standards and Procedures for the Appointment and Reappointment of United States Magistrate Judges, the Merit Selection Panel members will follow all guidelines and restrictions imposed by the Judicial Conference of the United States Courts. No person may be considered for selection by the court for a magistrate judge position while serving as a member of a panel and for a former panel member may not be considered for a subsequent magistrate judge position within one year from the date of submitted report to the court.

IT IS FURTHER ORDERED That this order shall become effective on February 28, 2024
