Noel Alexis Kapetanakos has been a party in the following cases in this Court:

Two of the cases were remanded to Cook County, and one was dismissed for failure to properly prosecute on a *pro se* basis.

In 11 CV 8805, *Kapetanakos v. Spellone et al*, Ms. Kapetanakos has been e-filing frivolous motions, notices of appeal, appellant's briefs, docketing statements, requests for review from the Iowa Supreme Court, and notices from the Illinois Board of Admissions to the Bar. After reviewing the docket, it appears that Ms. Kapetanakos is not following proper e-filing requirements.

It is the judgment of the Executive Committee that reasonable and necessary restraints must be imposed upon Ms. Kapetanakos's ability to e-file in this District.

IT IS HEREBY ORDERED BY THE EXECUTIVE COMMITTEE That any password issued to Noel Alexis Kapetanakos for access to the electronic filing system shall be disabled, and

IT IS FURTHER ORDERED That Noel Alexis Kapetanakos is authorized to submit to this court, no earlier than twelve months from the date of this order, a motion to modify or rescind this order, and

IT IS FURTHER ORDERED That nothing in this order shall be construed -----

- a) to deny Ms. Kapetanakos the ability to submit paper filings to this Court pursuant to the Local Rules of this Court and the Federal Rules of Civil Procedure,

- b) to affect Ms. Kapetanakos' ability to defend herself in any criminal action,
- c) to deny Ms. Kapetanakos access to the federal courts through the filing of a petition for a writ of habeas corpus or other extraordinary writ, or
- d) to deny Ms. Kapetanakos access to the United States Court of Appeals or the United States Supreme Court, and

IT IS FURTHER ORDERED That the Clerk shall cause to be created and maintained a miscellaneous file with the title "In the matter of Noel Alexis Kapetanakos " and case number 13 C 8792. The miscellaneous file shall serve as the repository of this order and any order or minute order entered pursuant to this order. The Clerk will also maintain a miscellaneous docket associated with the file. All orders retained in the file will be entered on that docket following standard docketing procedures. A brief entry will be made on the docket indicating the receipt of any materials from Ms. Kapetanakos, and

IT IS FURTHER ORDERED That the Clerk shall cause a copy of this order to be mailed to Ms. Kapetanakos at [REDACTED], Illinois 60690, the address given by Ms. Kapetanakos in documents received on December 5, 2013. Such mailing shall be by certified or registered mail, return receipt requested.
