It is the judgment of the Executive Committee that reasonable and necessary restraints must be imposed upon Ms. Levy's ability to file new civil cases in this District *pro se*. Cases in existence prior to the entry of this order are not affected by this order and shall proceed as usual.

**IT IS HEREBY ORDERED BY THE EXECUTIVE COMMITTEE** in its capacity as the supervisor of the assignment of cases, that the clerk is directed to return unfiled any documents or presentments submitted either directly or indirectly by or on behalf of Amanda U. Levy for a period of six months from the date of this order. A copy of this order shall be included with the returned documents, and

**IT IS FURTHER ORDERED** That no sooner than six months from the date of this order, Ms. Levy may submit documents or presentments for review by the Executive Committee, and

**IT IS FURTHER ORDERED** That any password issued to Amanda U. Levy for access to the electronic filing system shall be disabled, and


**IT IS FURTHER ORDERED** That Nothing in this order shall be construed -----

- a) to affect Ms. Levy's ability to defend herself in any criminal action,
- b) to deny Ms. Levy access to the federal courts through the filing of a petition for a writ of habeas corpus or other extraordinary writ, or
- c) to deny Ms. Levy access to the United States Court of Appeals or the United States Supreme Court, and

**IT IS FURTHER ORDERED** That the Clerk shall cause to be created and maintained a miscellaneous file with the title "In the matter of Amanda U. Levy" and case number 13 C 2544. The miscellaneous file shall serve as the repository of this order and any order or minute order entered pursuant to this order. The Clerk will also maintain a miscellaneous docket associated with the file. All orders retained in the file will be entered on that docket following standard docketing procedures. A brief entry will be made on the docket indicating the receipt of any materials from Ms. Levy, and

**IT IS FURTHER ORDERED** That the Clerk shall cause a copy of this order to be mailed to Ms. Levy at [REDACTED] Sacramento, CA 95812, the address given by Ms. Levy in documents received on March 25, 2013. Such mailing shall be by certified or registered mail, return receipt requested.
