It is the judgment of the Executive Committee that reasonable and necessary restraints must be imposed upon Mr. Matthews' ability to file new civil cases in this District *pro se*. Cases in existence prior to the entry of this order are not affected by this order and shall proceed as usual.

**IT IS HEREBY ORDERED BY THE EXECUTIVE COMMITTEE** in its capacity as the supervisor of the assignment of cases, that the clerk is directed to return unfiled any papers submitted either directly or indirectly by or on behalf of Kevin Matthews, Sr. A copy of this order shall be included with the returned documents, and

**IT IS FURTHER ORDERED** That Nothing in this order shall be construed -----

- a) to affect Mr. Matthews' ability to defend himself in any criminal action,
- b) to deny Mr. Matthews access to the federal courts through the filing of a petition for a writ of habeas corpus or other extraordinary writ, or
- c) to deny Mr. Matthews access to the United States Court of Appeals or the United States Supreme Court, and

**IT IS FURTHER ORDERED** That Kevin Matthews, Sr. is barred from seeking the assistance of the Pro Se Help Desk attorney, and

**IT IS FURTHER ORDERED** That any password issued to Kevin Matthews, Sr. for access to the electronic filing system shall be disabled, and

**IT IS FURTHER ORDERED** That Kevin Matthews, Sr. is authorized to submit to this court, no earlier than twelve months from the date of this order, a motion to modify or rescind this order, and

**IT IS FURTHER ORDERED** That the Clerk shall cause to be created and maintained a miscellaneous file with the title "In the matter of Kevin Matthews, Sr." and case number 11 C 7924. The miscellaneous file shall serve as the repository of this order, and any order or minute order entered pursuant to this order. The Clerk will also maintain a miscellaneous docket associated with the file. All orders retained in the file will be entered on that docket following standard docketing procedures.

**IT IS FURTHER ORDERED** That the Clerk shall cause a copy of this order to be mailed to Mr. Matthews at [REDACTED] Naperville, Illinois 60565, the address given by Mr. Matthews in documents filed on September 28, 2011. Such mailing shall be by certified or registered mail, return receipt requested.
