IT FURTHER APPEARING THAT in each case, the presiding judge entered a minute order stating,

"This court, upon reviewing the filing of a registration of a foreign judgment pursuant to 28 USC § 1963, has determined that such filing appears on its face to be frivolous, if not malicious and fraudulent. The court enters a temporary stay of any further proceedings on this filing and refers the matter to the Executive Committee for its consideration of this filing and any further proceedings therein and seven other similar filings by Ron Hertel and further to determine if Mr. Hertel should be prohibited from filing any further matters in this court without Executive Committee approval."


IT FURTHER APPEARING THAT after consideration, the Executive Committee for the Northern District of Illinois has determined that the original filings in each above-captioned case filed in the Western Division of the Northern District of Illinois shall be stricken, and Mr. Hertel shall be prohibited from filing further matters in the cases; therefore

IT IS ORDERED THAT the filings in each of the above-captioned cases are stricken; and

IT IS FURTHER ORDERED THAT Mr. Ron Hertel is prohibited from filing further matters in the above-captioned cases; and

IT IS FURTHER ORDERED THAT the Clerk shall cause a copy of this order to be mailed to Mr. Hertel at [REDACTED] Shannon, Illinois 61078, the address given by Mr. Hertel in documents filed on August 14, 2007. Such mailing shall be by certified or registered mail, return receipt requested.
