**EXECUTIVE COMMITTEE ORDER**

IT APPEARING THAT on September 23, 2005, an Executive Committee order was entered, directing the clerk of the United States District Court to return unfiled any papers submitted either directly or indirectly by or on behalf of Robert J. More and authorizing Robert J. More to submit to this court, no earlier than six months from the date of that order, a motion to modify or rescind the order, and

IT FURTHER APPEARING THAT since the entry of the above-referenced order, Mr. More has ignored the restrictions placed upon him by continuing attempt to file new cases, and

IT FURTHER APPEARING THAT a June 18, 2008 minute order entered in 08 C 1841, *More et al v. Lipkin and Higgins* states:

“Although the motions most recently filed in this case bear the name of Caroline More, the signature on these motions is not a close match for the signature on the earlier filed complaint and IFP application. Indeed, the (illegible) handwriting distinctly resembles the handwriting on motions submitted by Mr. Robert More, and it is Robert More, not his sister, who has appeared to present each and every one of the motions filed. These facts, considered together, give the court reason to worry that Mr. More has evaded this Court’s ban on his filings by simply submitting his motions in the name of another. . . . “

IT FURTHER APPEARING THAT at its September 10, 2008 meeting, the Executive Committee denied Mr. More leave to file his documents submitted on June 19 and June 23, 2008, now therefore

IT IS ORDERED THAT the order of September 23, 2005 shall remain in force for an additional six months, and


IT IS FURTHER ORDERED THAT the order of September 23, 2005 is amended to direct the clerk to destroy any documents submitted directly or indirectly by or on behalf of Robert J. More, and

IT IS FURTHER ORDERED THAT Mr. More is prohibited from aiding in the filing or presentation of the cases of other parties, and

IT IS FURTHER ORDERED THAT Mr. Robert J. More may submit to this court, no earlier than six months from the date of this order, a motion to modify or rescind the order entered on September 23, 2005 and modified on September 17, 2008, and

IT IS FURTHER ORDERED THAT the Clerk shall cause a copy of this order to be mailed to Mr. Robert J. More at [REDACTED] Chicago, Illinois 60680, the address given by Mr. More in papers filed on June 19, 2008. Such mailing shall be by certified or registered mail, return receipt requested.
