## **POSITION OVERVIEW**

This temporary position is located within the United States District Court for the Northern District of Illinois Clerk's Office in Chicago, Illinois and reports directly to the Clerk of Court. The Architect/Project Manager oversees construction and demolition projects affecting the courthouse and its space. Responsibilities include, but are not limited to, project management, design, development, oversight, and coordination. Duties may require working during non-business hours.

# **POSITION DUTIES AND RESPONSIBILITIES**

- Oversee for the judiciary, the project authorized by the Consolidated Appropriations Act, 2022, signed into law March 15, 2022. Work includes the process to comply with obligations under the National Environmental Policy Act (NEPA) and Section 106 of the National Historic Preservation Act (NHPA).
- Monitor the design and renovation process, to include review of drawings, specifications, schedules, cost estimates, and other documents to ensure compliance with general project integrity, conformity, and quality. Ensure that judiciary requirements are met by the General Services Administration (GSA) and its contractors in accordance with the U.S. Courts Design Guide, United States Marshal Service Publication 64 and GSA's P100, and Pricing Desk Guide.
- Provide technical advice and recommendations to judges and the Clerk of Court to assist in defining court design, construction, demolition, or renovation needs.
- Direct and assume responsibility for all phases of the project, including all design and construction aspects through project close-out stages.
- Provide day-to-day project management expertise including long-term plans and goals.
- Participate in and coordinate construction meetings with all concerned parties to review progress, discuss problems, and develop solutions. Ensure all concerned parties are advised of requirements, changes, problems, and provide potential solutions.
- Prepare and present periodic reports on project status and/or funding requirements to judicial officers and unit executives. Maintain project log of Court actions, desires, and preferences related to the project.

#### Architect/Project Manager

- Utilize software developed for computer assisted drawing and similar computer design technology to develop layouts, plans, blueprints, and designs.
- Serve as liaison for the Court with GSA, other governmental agencies, third party architectural/engineering firms and outside vendors. Ensure the completeness and timeliness of project delivery.
- Review schedules provided by GSA and contractors to insure there are no delays which impact project phases or changes that alter operational characteristics of the project.
- Coordinate project security issues with the U.S. Marshals Service as they relate to Court space.
- Perform other related duties, as assigned or required.

# JOB REQUIREMENTS AND QUALIFICATIONS

Applicants for this position must have a bachelor's degree from an accredited college/university in architecture, engineering, industrial design, or a related field. Applicants must also have at least four years of specialized experience in construction or space and facility oversight involving major project development, space coordination and design. Prior experience must include direct project management, oversight, scheduling, coordination, and problem solving all aspects of new building construction and/or demolition. Candidates must be able to analyze architectural drawings and designs, interpret their content and provide accurate, concise briefings and recommendations to the Chief Judge, Clerk of Court and other Court staff. Candidates must be self-directed, highly organized with superior analytical skills, well developed in organizational and time management skills. Candidates must also possess excellent communication skills, including the ability to present complicated, technical matters to individuals and groups with varying technical knowledge. Candidates must be able to interact effectively with others, provide excellent customer service and be able to resolve difficulties with complying with rules and regulations. As a condition of employment, the selected candidate must successfully complete a background investigation.

Prior experience working on federal projects, or projects involving National Environmental Policy Act, National Historic Preservation Act as well as Chicago and Illinois Historic Preservation processes is preferred.

## **COMPENSATION**

Compensation and classification level will be set based on the work experience, qualifications, and salary history of the successful candidate. To qualify at the CL 29 level, applicants must have two years of specialized experience, including at least one year equivalent to work at the CL 28 level. To qualify at the CL 30 level, applicants must have two years of specialized experience, including at least one year equivalent to work at the CL 29 level. #### **NOTICE TO APPLICANTS**

Due to the volume of applications received, the Court will only communicate with those applicants who will be interviewed. Applicants selected for interviews will be communicated to only through email and must travel at their own expense and relocation expenses will not be reimbursed. Applicants will be screened to determine their experience and qualifications.

#### INFORMATION ABOUT THE NORTHERN DISTRICT OF ILLINOIS

The Northern District of Illinois is home to the five largest cities in Illinois: Chicago, Aurora, Rockford, Joliet, and Naperville. Also known as "The Windy City," Chicago is the third most populous city in the U.S. with over 2.7 million inhabitants and nearly 10 million people living in the Chicago metropolitan area.
