GENERAL ORDER 24-0027**

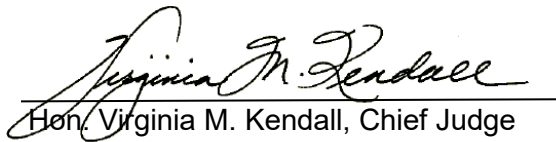
