## STANDARD VOIR DIRE QUESTIONS IN JURY TRIALS BEFORE JUDGE MARTIN

- 1. Your name and age.
- 2. The community or neighborhood (not the street address) and any other places where you have lived in the past 10 years.
- 3. How long you have lived in your current home, and whether you rent or own your home.
- 4. Where you were raised.
- 5. How far you went in school, including where you attended high school, college, and any post-graduate institution.
- 6. Whether you have served in the military, and if so, the branch of service, the years that you served, your highest rank and nature of discharge.
- 7. Your employment or self-employment information for the past 10 years, with such details as:
  - (a) the name and place of your employment or self-employment;
  - (b) your title and a description of your work responsibilities;
  - (c) length of time of your employment, self-employment or unemployment.
- 8. Other family and employment information:
  - (a) Your marital status.
  - (b) If married, your spouse's name and the same employment (or self-employment) information as listed above for the past 10 years.
  - (c) If you have children, their names and ages and the same employment (or self-employment) information during the past 10 years for each of them, and if any of them is married, the same employment (or self-employment) information about each daughter-in-law or son-in-law.
  - (d) If any other adult lives in your household (any parent, brother, sister, fiancé, boyfriend or girlfriend or anyone else), the same employment (or self-employment) information about each such person during the past 10 years.
- 9. Your major outside interests or hobbies -- things that you spend significant time doing outside of work (e.g., clubs, groups, watch TV).
- 10. Membership in any organizations (work-related, social, civic, community, etc.).
- 11. What types of things you like to read, including what magazines and/or newspapers you subscribe to or read regularly. If you read books, what types of books do you read?

- 12. What TV shows you watch regularly.
- 13. Whether you have any legal training or experience, either through formal classes or experience on-the-job.
- 14. Any prior jury experience in federal court, state court or on the grand jury, including what court, when, type of case, and outcome of case.
- 15. Whether you have ever been a party to a civil lawsuit, other than a divorce case: have you, a relative or close friend have ever sued someone or been sued? Include any lawsuit that you have been involved in related to your employment or occupation.
- 16. Whether you have ever been a defendant or a witness in a criminal case.
- 17. Any prior experience as a witness in any court, hearing or deposition.
- 18. Whether you have any problems seeing or hearing or any medical problems of any kind that could interfere with your ability to serve as a juror.
- 19. Whether you need any accommodations (physical or otherwise) to enable you to serve as a juror.
- 20. Whether you are aware of any facts or circumstances that might affect your ability to be objective and fair to both sides in the case.
- 21. Whether you have any philosophical, religious or other beliefs that would prevent you from rendering a verdict in this case.
- 22. Whether you, any family member, or any close friend are now or have ever been an attorney, a law-enforcement officer, a correctional officer, an investigator for any agency or corporation, a paralegal, a judge, or a member of any courtroom staff or courthouse personnel.
