Any quote that is deemed incomplete will be considered technically unacceptable. Pricing is to be provided on the attached quote sheet and must be answered in its entirety. It is the sole responsibility of the vendor to confirm receipt of its bid with the U.S. District Court. A fixed price award from this RFQ will be made based on the lowest priced, technically acceptable offer for the base year and two option years. Technical requirements are listed below. Successful bidder must be willing to accept a Purchase Order. By Federal Law, the Issuing Organizations (IO) must pay in arrears.

Questions concerning this RFQ must be submitted in writing to Theresa Poindexter at the above listed email address by Thursday, August 10, 2017. Answers to all questions will be provided to all bidders Tuesday, August 15, 2017.

## 1 Requirements

The IOs are seeking quotations for monthly cellular service for 177 smartphones and 1 basic phone. The IOs will bring our own devices. This RFQ is for monthly cellular for 177 phones and 1 basic phone with month-to-month services for the period of September 16, 2017*-September 15, 2018 with two option years depending on need and the availability of funding. Option Year 1:
September 16, 2018-September 15, 2019, Option Year 2: September 16, 2019-September 15, 2020.

The following are the voice needs for the $\mathbf{1 7 7}$ smartphone cellular devices on this RFQ: The usage shall be 400 pooled anytime minutes per user with unlimited night and weekend minutes, unlimited mobile-to-mobile minutes and unlimited messaging. Unlimited messaging is to include text, video, picture, and IM messaging. Service must be nationwide. The IOs will also require three wireless priority system capable lines. Local coverage may be provided on a GSM or CDMA network.

The following are the voice needs for $\mathbf{1}$ basic phone (no data requirement) on this RFQ: The usage shall be 400 pooled anytime minutes per user with unlimited night and weekend minutes, unlimited mobile-to-mobile minutes and unlimited messaging. Unlimited messaging is to include text, video, picture, and IM messaging. Service must be nationwide. Local coverage may be provided on a GSM or CDMA network.

The following are the international roaming activation and deactivation requirements for this RFQ: International roaming activation and deactivation must be able to be turned on and off for users individually upon request for any duration of time. Use of quality, reliable GSM towers abroad is required. Comprehensive coverage maps including pricing broken down by country, including all roaming fees and any other fees for this service must be provided. Approximately 30 requests are made each year for activating and deactivating international coverage. The most traveled cities and countries are Africa, Guatemala, Cayman Islands, Thailand, Curaco, Mexico, Merida, China, Japan, and Belize.

The following are the data needs for the cellular devices on this RFQ: Unlimited enterprise data for hot spot service, email and web browsing.

### 1.1 Service Enabling Devices

The IO will bring its own devices. Service provider must allow IO to use its own devices.

### 1.2 Emergency Replacement of Devices

Emergency replacement of lost or broken devices is a requirement or a factor in the evaluation of the quotations. Devices must be replaced within 48 hours of reported need.

### 1.3 Pre-Existing Agreements and Government Furnished Equipment

There is a pre-existing agreement in place for the devices that this RFQ is looking to replace: 1. All of the devices ( 177 iPhones, and 1 basic phone) must transition to the new agreement by September 16, 2017.
2. The current carrier for these lines of service is AT\&T and the agreement is set to expire on September 15, 2017.
3. On-site support by the contractor is required for the porting of all existing numbers.

### 1.4 Price Reductions

In accordance with FAR 8.405-4, the IO is requesting additional price reductions to the BPA prices.

### 1.5 Delivery

1. Full performance for the order is scheduled to begin September 16, 2017, and complete on September 15,2018 , with two additional option years that the IOs may elect to adopt.

## 2 Basis for Award

While award will be made to the lowest priced, technically acceptable offer, bidders must meet the following minimal technical requirements listed in order of importance to be considered for the award:

1. Coverage - International Roaming (voice, data and text) must be available on a GSM network. Local coverage may be provided on GSM or CDMA network. Provider must guarantee coverage for the Northern District of Illinois. A map of the Northern District of Illinois is included in the RFQ as attachment one. Quotations must include coverage maps: a local map detailing coverage in the Northern District of Illinois, a Nationwide map and International maps. Broadest coverage in these three distinct areas will be considered when evaluating the quotes. Pricing for both domestic and International Service, including per minute and fees, will be considered as a basis for the award.
2. Remaining requirements listed in the requirement section above.
3. Must provide itemized billing for each line of service with one master bill.
