This equipment listed is being offered as one whole lot. Bidders are invited, urged, and cautioned to inspect the property prior to submitting a bid. The Court makes no warranty, expressed or implied, as to the quantity, kind, character, quality, weight, size, or description of any of the property, or its fitness for any use or purpose. No request for adjustment in price or for rescission of the sale will be considered.

The equipment is available for inspection upon request during the bidding period at the Everett McKinley Dirksen United States Courthouse, 219 South Dearborn Street, Chicago, Illinois 60604. Arrangements for inspection must be made no less than 48 hours in advance. Email kelli_chamberlain@ilnd.uscourts.gov to schedule an inspection. Interested parties must be prompt and arrive prior to inspection times in order to be included, there will be no exceptions.

The deadline for submitting your offer for the equipment is August 15, 2022, by 5:00 PM (Central Time). Your offer must be emailed to kelli_chamberlain@ilnd.uscourts.gov. Your offer must include a copy of the bid form attached below. It is the sole responsibility of the purchaser to confirm the receipt of the offer by the Court. The highest bidder will be notified no later than the close of business on August 16, 2022.

Payment to the Court is to be made prior to the removal of all of the equipment. The payment must be made by **certified check**. The check must be made out to the **Administrative Office of the United States Courts**. Removal of the equipment must be scheduled by August 23, 2022, and must be removed by August 30, 2022. It will be the responsibility of the successful bidder to remove the equipment off site during building/business hours of 8:00 a.m. - 5:00 p.m., Monday - Friday, excluding Federal Holidays. Dock time must be scheduled in advance and kept to an absolute minimum; please plan on bringing an adequate number of workers to load equipment.

Delivery trucks are limited to straight trucks a maximum of 10' high. The Everett McKinley Dirksen United States Courthouse is a Federal building that has security measures in place. Each person who enters the building must have a valid state ID or drivers license. All persons entering the courthouse must abide to all security procedures set forth by the U.S. Marshal Service.
