The Way Forward: Findings from the Survey on Women Lawyers as Lead Counsel and Trial Counsel in Litigation

Stephanie Scharf and Roberta Liebenberg conducted the study and wrote "First Chairs at Trial: More Women Need Seats at the Table, A Research Report on the Participation of Women Lawyers as Lead Counsel and Trial Counsel in Litigation" based on a random sample of all cases filed in 2013 in the Northern District of Illinois. They used the Pacer system and randomly selected 558 civil cases and 50 criminal cases. The findings from their study and recommendations for best practices going forward will be discussed.
